AGENDA ITEM: Approval of Addendum for Repairs at Biwabik Park Pavilion

BACKGROUND: All Slopes roofing removed the shingles from the area above the kitchen in the pavilion and found that the wood was rotted and spongy from all the water that seeped in over the years.

They provided a contract addendum to replace the rotted wood, install a rubber membrane and flashing as needed, and then replace the siding on that section of the wall.

There are two options for funding this project. We recently received the \$28,000 from the Senior Center after they disbanded. We could also potentially use CARES funding (pandemic related assistance) as the pavilion is our designated disaster shelter.
